**DETAILS OF REPRESENTATIVE NOMINATED TO THE STAKEHOLDERS  
CONSULTATION COMMITTEE**

This is in reference to the Order of the Hon'ble National Company Law Tribunal, New Delhi ("NCLT"), dated January 20, 2025, which commenced the liquidation of Go Airlines (India) Limited ("Corporate Debtor") and appointed Mr. Dinkar T. Venkatasubramanian as the Liquidator ("Liquidator") of the Corporate Debtor.

Pursuant to the Notice dated October 22, 2025 for reconstitution of the Stakeholders' Consultation Committee ("SCC") published on the website of the Corporate Debtor, the Liquidator facilitated a process for nominating representatives to the SCC for each class of creditors, other than the financial creditors, for participation in the SCC of the Corporate Debtor. Please note that the SCC has been reconstituted the basis of the List of Stakeholders dated October 15, 2025, as published on the website of Corporate Debtor and the nominee who received a majority basis the voting within the portal and have consented to act as the representative of the particular class have been appointed as the representative for the particular class of creditors in the SCC.

Based on the aforesaid e-voting and actions undertaken by the Liquidator, and in furtherance to the details of representative published on November 24, 2025, the following representative has now been declared as the representative of the following class of creditors:
